UNION COUNTY RESOLUTION NO: 20-06

WHEREAS, the Union County Board of County Commission is charged through Florida Statutes 252.38 Section (1) (a) to establish a plan which shall provide for county wide emergency planning and coordination of the response and recovery of major incidents and disasters; and

WHEREAS, the Florida Division of Emergency Management (FDEM) has completed its review of the Union County Comprehensive Emergency Management Plan (CEMP) and it was determined that the Union County has met the CEMP compliance criteria; and the approved plan must now be adopted by resolution by the Board of County Commissioners; and

WHEREAS, the agencies and entities with responsibilities for response and recovery emergency support functions are identified in the plan with specific instructions as to when, where and how those agencies shall respond to the local state of emergency as declared by the Board of County Commissioners; and

WHEREAS, those agencies have been educated and informed of the plan's requirements for those identified entities of agencies planning for the response to and recovery of their emergency support function outlined in the plan; and

WHEREAS, to facilitate the most efficient and effective incident management it is critical that Federal, State and local organizations utilize standardized terminology, standardized organizational structures, interoperable communications, consolidated action plans, unified command structures, uniform personnel qualification standards, uniform standards for planning, training and exercising, comprehensive resource management, and designated incident facilities during emergencies or disasters; and

WHEREAS, the NIMS standardized procedures for managing personnel, communications, facilities and resources will improve the County's ability to utilize Federal funding to enhance local agency readiness, maintain first responder safety and streamline incident management processes; the Incident Command System components of NIMS are already an integral part of various incident management activities throughout the State, including current emergency management training programs.

NOW, THEREFORE, BE IT RESOLVED, that the Union County Board of County Commissioners does hereby adopt the Union County Comprehensive Emergency Management Plan (CEMP), the master copy of which is maintained and housed by Union County Emergency Management as the protocol to be followed by all agencies in the County identified in the plan as authorized by law through the enactment of any declaration of a local state of emergency.
