ADOPTING THE FINAL TAX LEVYING OF AD VALOREM FOR UNION COUNTY FISCAL YEAR 2022-2023;
PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Board of County Commissioners of Union County, Florida on September 25, 2023
Adopted Fiscal Year 2023-2024 Final Millage Rate following a Public Hearing as required by Florida
Statute 200.065; and

WHEREAS, the Board of County Commissioners of Union County, Florida held a Public Hearing as
required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Union
County has been certified by the County Property Appraiser to the Board of County Commissioners
of Union County, Florida as \$344,666,534

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Union County, Florida,
that:

1. The Fiscal Year 2023-2024 operating millage rate for is 10 mills which is a 6.09% increase to the rollback rate of 9.4257
2. The Fiscal Year 2023-2024 voted millage rate for the Union County Public Library MSTU
is .50 mills.
3. The Resolution shall take effect immediately upon its adoption.
